





## [ CPD Continuing Professional Development]

#### [INTRODUCTION]

The main purpose of this booklet is to set out the guidelines for the implementation and requirements of ILAM CPD for Landscape Architects. This booklet will also provide guidelines on how Landscape Architects can participate, record and monitor their CPD activities to meet ILAM CPD requirements.

#### [ DATE OF IMPLEMENTATION ]

With effect from 1st January 2014, it is mandatory for all Landscape Architects to participate and maintain records of their participation in CPD. The trial period is 3 years with full implementation by January 2017.

All renewals of registration with the Institute, for the year 2014 onwards, must include evidence that they have undertaken activities to accumulate the required minimum CPD credit points.

#### [ CPD REQUIREMENTS ]

#### Landscape Architects who are subjected to CPD

The following categories of Landscape Architect are subjected to CPD:-

- Registered Landscape Architect and Graduate Landscape Architect.
- Registered Landscape Architect whose registration has been cancelled and desires reinstatement of registration.
- Registered Landscape Architect whose registration has been suspended and desires reinstatement of registration.
- Registered Landscape Architect who has failed to renew registration and desires reinstatement of registration.

#### **CPD Requirements for Reinstatement of Registration**

- Landscape Architect whose registration is cancelled, suspended or failed to renew his/her registration for a period of more than one (1) year is required to comply with the ILAM CPD requirements for the year prior to the reinstatement.
- Landscape Architect whose registration has been cancelled or suspended or has failed to renew his/ her registration for a period of less than one (1) year, the number of CPD credit points required shall be proportionate to the period their registration has been cancelled or suspended or lapsed in the preceding year.

#### **CPD Event and Accreditation**

Any party other than ILAM, who wishes to organise or participate in any ILAM CPD events with the intention of obtaining 'CPD credit points' must apply in writing to ILAM for accreditation at least two (2) months before the proposed date of the event. ILAM will decide on the number of credit points and the decision made by ILAM on this matter is final.

The qualifying events are as listed in this brochure and should focus on topics related to the core skills and knowledge of the Landscape Architecture profession including topics that enhance knowledge development.

#### Landscape Architect exempted from CPD

The following categories of Landscape Architect are exempted from CPD:-

- 1. Being above the age of 60 years old
- 2. Past President of ILAM
- Senior Government Officers or Elected Representatives to the State Legislative Assembly or Parliament of Malaysia
- 4. Fellow members of ILAM

**Note:** Application for exemption must be made to ILAM before 31<sup>st</sup> December of the year preceding the year for renewal of registration.

#### **FADMINISTRATION OF CPD COMPLIANCE 1**

Unless exempted by ILAM, an application for renewal of registration shall comply with the following requirements.

#### Maintenance of CPD record

From time to time, ILAM may request the Landscape Architect to provide evidence of their participation in CPD events. Landscape Architects shall maintain all relevant documents and certificates of attendance as proof of their participation.

#### **Submission of CPD record**

A Landscape Architect must submit the CPD record, together with his/her application for renewal of registration with ILAM. Applicants must complete and submit on the ILAM membership database portal, **www.ilamdatabase.com**, together with all supporting documents for ILAM's verification and approval.

#### **Non-Compliance of CPD Requirements**

An application for a renewal of registration will not be approved if the applicant does not comply with the CPD requirements, unless ILAM has approved such non-compliance.

#### **Excess Credit Point**

Only Registered Landscape Architects who have recorded excess CPD credit points may carry forward such excess credit points to the subsequent year.

Landscape Architects who intend to carry forward their excess credit points must submit to ILAM their current and previous year's CPD records for verification.

#### **False Declaration**

ILAM shall revoke the registration of any Landscape Architect if the approval for renewal of registration was obtained by means of false declaration regarding CPD requirements.

## [ EXPLANATORY NOTES ON CPD CREDIT POINT TABLE ]

Landscape Architects are encouraged to participate in CPD events organised by ILAM and accumulate the required credit points per year to be eligible to submit an application for renewal of registration in the preceding year.

In carrying out CPD events, from time to time, ILAM may accredit professional bodies where Landscape Architects may obtain CPD credit points by serving as committee and/or sub-committee members, or attend seminars, conferences, workshops, CPD talks, short courses or technical visits organised by approved professional partners.
